Gerad Johnson, A.G.E Corp, returned for discussion concerning the Peterson Park wall failure situation. Several proposals were discussed without any formal bid presentation. The project was tabled for further discussion.

Parks Chairman Matt Mitchell will continue talks with contractors concerning improvements at Railway Park. As soon as weather cooperates, it is hoped that work can begin. Dirt work and concrete work are included in the plans. Cullen Deis will be contacted for a bid on replacing/rerouting the sprinkler system as needed following the Railway Park improvements.

Social Committee is still waiting for favorable conditions for a gathering. With the new ownership at Dudley's Tap, now Tiger's Tap, it is uncertain if MGHOA events can be held there. More to come later this spring.

Memorials for Dan Davis and Robert Bak were approved. Donations were discussed benefiting the Community Youth Involved Center and Fort Pierre Legion Post. The organizations will receive the donation in Robert and Dan's name respectively. Motion by Weisgram/second by Nelsen. Motion approved.
