Marion's Garden HOA Meeting Minutes

The monthly MGHOA meeting was called to order Tuesday, October 14th, at 7:05pm at Zach Clark's storage building. Present were President Marlin Roseland, Vice President Zack Clark, Secretary Todd Bowman, and Board Member Evan Protexter. Board Member Gary Johnson attended via cell phone. Financials / Bills:

Walti was absent so financials were not discussed. The Board received a bill from Aaron Swan and Associates shortly after the September meeting, and the Board felt it necessary to get this bill paid rather than wait for the next meeting. Via email, Johnson motion to approve the \$4,088.70 bill for work performed, Tellinghuisen second. Motion carried via email vote.

Roseland submitted one bill for consideration: Hanson Lawn Care for \$743.40. Johnson motioned to pay the bill: Clark seconded. Motion carried on a unanimous voice vote.

Old Business:

Committee Reports:

Canal: Weisgram presented the preliminary report from ISG on the canal wall. ISG classified the areas of the wall based on the following conditions:

- Poor: immediate wall repair or replacement recommended, within the next year
- Fair: wall repair or replacement recommended in the short-term, within the next 2 to 4 years
- . Good: wall repair or replacement recommended in the mid-term, within the next 5 to 10 years
- Great: perform regular maintenance and monitoring over the long-term, over the next 10-20 years

There are currently four areas that are Poor and in need of immediate repair, and we are now waiting for the next step from ISG for recommendations to perform immediate repairs, as well as repairs into the future. Weisgram stated he would contact ISG to determine what remaining services are within our contract regarding repair recommendations. The ISG report was well received and solidified the Boards prior concerns regarding immediate wall repairs. A bill of \$7,965 was presented for the current services. Johson moved to approve payment of the bill, Clark seconded. Motion carried on a unanimous voice vote.

Architectural: a four-season room was approved at a residence.

Parks & Playgrounds: Spinklers will be blown out soon.

New Business: Long-time resident of the development LaVonne Regan recently passed away, and the Board suggested a \$100 memorial. Roseland motioned to approve the memorial, Clark seconded. Motion carried.
